At no time during the year was the Association a party to any transaction, arrangement or contract in which a member of the GC of the Association had, directly or indirectly, a material interest.

### **Auditor**

Baker Tilly Hong Kong Limited retires and, being eligible, offers themselves for re-appointment. A resolution for the re-appointment of Baker Tilly Hong Kong Limited as auditor of the Association is to be proposed at the forthcoming AGM.

**Business review**

**Overview of the Operation and Annual Performance**

The Beat Drugs Fund (the Fund) was established in 1996 with a capital base of HK\$350 million to provide funding support for worthwhile anti-drug projects through its investment income. It is administered by the Beat Drugs Fund Association (the Association), which is a non-profit making company limited by guarantee incorporated under the Companies Ordinance (Cap. 622). A Governing Committee (GC), comprising both official and non-official members, is set up to oversee the administration and investment of the Fund, as well as to consider and approve funding applications, having regard to the recommendations of relevant Government bureaux and departments, as well as the Action Committee Against Narcotics (ACAN).

The Government injected HK\$3 billion into the Fund in 2010, increasing the capital base to HK\$3.35 billion.

**Principal Activities Performance**

Taking into account the emerging needs of certain areas of anti-drug work, the GC, in consultation with ACAN, has launched various funding schemes, including –

- (a) the Regular Funding Scheme (RFS) which supports community-driven anti-drug activities and programmes on preventive education and publicity (PE&P), treatment and rehabilitation (T&R), and research;
- (b) the Special Funding Scheme (SFS) for Drug Dependent Persons Treatment and Rehabilitation Centres (DTRCs) which provides financial assistance to help DTRCs meet the licensing requirements stipulated in the Drug Dependent Persons Treatment and Rehabilitation Centres (Licensing) Ordinance (Cap. 566) with a view to obtaining a licence and supporting sustained efforts in enhancing service capacity and sophistication. It also covers the works connected with the in-situ expansion or redevelopment/re-provisioning of existing DTRCs;
- (c) the Healthy School Programme with a Drug Testing Component (HSP(DT)) which is a school-based preventive education initiative for implementation in secondary schools, comprising preventive anti-drug activities and voluntary drug testing;
- (d) the Anti-drug Community Awareness Building Programme (ACAB) which is implemented in collaboration with the District Fight Crime Committees (DFCCs) and District Offices for launching preventive initiatives to enhance the anti-drug awareness in the local communities; and
- (e) the "Participate in Sports, Stay Away from Drugs" Programme (the Sports Programme) which is a school-based student-led preventive education initiative for implementation in secondary schools and aims to promote healthy lifestyles and an anti-drug culture.

In 2018-19 financial year, the funding grants and activities of the five schemes are set out in the ensuing paragraphs.

• *RFS*

Applications under the 2018 RFS were invited in August 2018. Specific priority areas were drawn up with reference to various factors including prevalent drug trends and pertinent service needs to encourage quality submission of proposals for anti-drug projects meeting the community needs.

In 2018-19 financial year, a total of 61 projects covering PE&P, T&R, research and mixed-type projects were approved under the RFS, with a total funding grant of about HK\$123.74 million.

- SFS

In 2018-19 financial year, no new project was approved under the SFS. Meanwhile, there are eight ongoing projects.

- HSP(DT)

In 2018-19 financial year, the GC approved a grant of about HK\$76.14 million for 63 secondary schools and their partnering non-governmental organisations (NGOs) to implement the HSP(DT) for one school year, two consecutive school years or three consecutive school years. This brought the total number of schools participating in the programme to 155.

- ACAB

The Fund launched the first round of ACAB on a trial basis in 2013. Noting the merits of the ACAB and the need to sustain the momentum in community-driven anti-drug work, the GC approved the launch of the second (from 1 April 2015 to 31 March 2018) and third round (1 April 2018 to 31 March 2021) of ACAB. For the third round of ACAB launched in April 2018, each DFCC has been granted a maximum of HK\$380,000.

- *Sports Programme*

The Sports Programme was launched on a trial basis in the 2017/18 school years. Having received positive feedback and comments, the GC approved in the 2018-19 financial year a grant of about HK\$2.7 million for 136 secondary schools to continue to implement the Sports Programme on a trial basis in the 2018/19 school year.

Information on the approved active RFS projects up to 31 March 2019 is shown at Annex A. A summary of approved grants and outstanding commitments of all funding schemes as at 31 March 2019 is shown at Annex B.

#### Financial Indicators

The Fund's investment portfolio is expected to fetch over time a return of about 4% per annum to provide financial support to anti-drug projects. For the financial year ended 31 March 2019, the Fund recorded a return of about 2.7%.

For the profit or loss and details of income information of the Fund, please refer to page 11 of the reports and financial statements.

#### **Description of the Principal Risks and Uncertainties Facing the Association**

A detailed analysis of the Fund's financial risks, including credit risk, liquidity risk, currency risk, interest rate risk, equity price risk and other financial risks, is set out in note 13 to the financial statements.

#### **Looking Ahead**

Over the years, the Fund has provided substantive grants to support worthwhile anti-drug projects. The Association will continue to sustain efforts to support anti-drug projects that could respond to the changing drug scene and rise to challenges of new threats.

In the coming year, the Association would continue to work with ACAN to draw up specific priority areas for the RFS to guide applicants in planning suitable anti-drug projects in response to the latest drug scene. The Association would continue to provide funding support under the SFS to DTRCs in fulfilling statutory licensing requirements. Efforts would continue to

progressively roll out the HSP(DT) to more secondary schools to help foster a drug-free culture in schools. The Sports Programme would continue to be implemented in the 2019/20 school year in view of the positive feedbacks and comments collected during its trial implementation in the 2017/18 and 2018/19 school years.

### **Environmental Policy and Performance**

The Association is committed to achieving environmental protection. We adopt environmental-friendly policies, which are consistent with the government requirement. We also advocate the importance of environmental protection. Project grantees are also encouraged to adopt environmental-friendly measures in project implementation.

### **Compliance with Relevant Laws/Regulations with Significant Impact**

The Association endeavours to comply with all relevant laws and regulations, and there is no compliance matter with significant impact.

### **An Overview of the Association's Relationship with its Stakeholders**

#### Advisory Bodies

As the Government's main advisory body on anti-drug policies and programmes, ACAN closely monitors the latest drug situation and conducts periodic reviews on the priorities of anti-drug measures, taking into account relevant factors such as the latest drug trend, updated anti-drug policies and strategies, feedback from relevant sectors, etc. Advice of ACAN provides an important reference to the Association in determining the direction and work plan of the Fund, as well as ensuring the effective deployment of funds to meet emerging needs in the anti-drug cause.

The investment strategies of the Fund are formulated and executed within the scope approved by the Association on advice of its Investment Sub-Committee.

#### Collaborating with NGOs/Engaging Practitioners

Apart from partnership with the advisory bodies, the Association maintains a good collaborative relationship with various NGOs and practitioners in the medical, education, social services and private sectors in promoting anti-drug projects which help to tackle the drug problem in Hong Kong.

On the T&R front, the Association maintains a close relationship with the anti-drug sector and relevant stakeholders in the social services, medical and other related sectors to enable the provision of holistic treatment and rehabilitation services for drug abusers and help minimise their relapse through strengthened cross-sectoral collaboration. The Association also works closely with partners to promote training and sharing of good collaboration practices to enhance the skills and knowledge of frontline workers and healthcare professionals in handling the increasingly complex psychotropic substance abuse cases.

On the PE&P front, the school is an important platform for cultivating a drug resistant attitude among young people. The Association engages the school sector, including school sponsoring bodies and relevant stakeholders, to promote the implementation of the HSP(DT) and the Sports Programme. The Association also maintains close collaboration with DFCCs and community stakeholders to widen the district anti-drug network and empower members of the community such as parents/family members, and relevant community stakeholders in the furtherance of the anti-drug cause.

**Opinion**

We have audited the financial statements of Beat Drugs Fund Association (the "Association") set out on pages 10 to 35, which comprise the statement of financial position as at 31 March 2019, and the statement of profit or loss and other comprehensive income, the statement of changes in funds and the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the financial statements give a true and fair view of the financial position of the Association as at 31 March 2019 and of its financial performance and cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the Hong Kong Companies Ordinance.

**Basis for opinion**

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the HKICPA. Our responsibilities under those standards are further described in the "Auditor's responsibilities for the audit of the financial statements" section of our report. We are independent of the Association in accordance with the HKICPA's Code of Ethics for Professional Accountants (the "Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. The Governing Committee ("GC") of the Association is responsible for the other information. The other information comprises the information included in the GC's report and the business review, but does not include the financial statements and our auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

As part of an audit in accordance with HKSAs, we exercise professional judgement and maintain professional skepticism throughout the audit. We also:





**1. General information**

Beat Drugs Fund Association (the "Association") was incorporated on 28 March 1996 in Hong Kong with its liability limited by guarantee. The registered office of the Association is located at Narcotics Division, Security Bureau; 30/F., High Block, Queensway Government Offices, 66 Queensway, Hong Kong.

The Association operates as a non-profit making association to promote worthwhile anti-drug activities.

These financial statements are presented in Hong Kong dollars, which is the same as the functional currency of the Association, and all values are rounded to the nearest thousand except where otherwise indicated.

**2. Significant accounting policies**

(a) Statement of Compliance

These financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which is a collective term that includes all applicable individual HKFRSs, Hong Kong Accounting Standards ("HKAs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), and accounting principles generally accepted in Hong Kong. These financial statements also comply with the applicable requirements of the Hong Kong Companies Ordinance. A summary of the significant accounting policies adopted by the Association is set out below.

The HKICPA has issued certain new and revised HKFRSs that are first effective or available for early adoption for the current accounting period of the Association. Note 2(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Association for the current and prior accounting periods reflected in these financial statements.

(b) Basis of preparation of the financial statements

The measurement basis used in the preparation of the financial statements is historical cost except that financial assets at fair value through profit or loss and trading financial instruments are stated at fair value as explained in the accounting policies set out below.

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and the reported amounts of assets and liabilities, income and expenditure. The estimates and associated assumptions are based on experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis for making judgements about the carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

(b) Basis of preparation of the financial statements (cont'd)

There are no critical accounting judgements involved in the application of the Association's accounting policies. There are neither key assumptions concerning the future, nor other key sources of estimation uncertainty at the reporting date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities in the next year.

(c) Changes in accounting policies

The HKICPA has issued a number of new HKFRSs and amendments to HKFRSs that are first effective for the current accounting period of the Association. Of these, the Association has adopted the requirements of HKFRS 9 "Financial Instruments" from 1 April 2018.

HKFRS 9 replaces HKAS 39 "Financial Instruments: Recognition and Measurement". It sets out the requirements for recognising and measuring financial assets, financial liabilities and some contracts to buy or sell non-financial items.

The Association has applied HKFRS 9 retrospectively to items that existed as at 1 April 2018 in accordance with the transition requirements without restating comparative information (i.e. the comparative information continues to be reported under HKAS 39). The carrying amounts of the items as at 1 April 2018 have not been impacted by the initial application of HKFRS 9.

Further details of the nature and effect of the changes to previous accounting policies are set out below:

(i) Classification of financial assets and financial liabilities

HKFRS 9 categorises financial assets into three principal classification categories: measured at (i) amortised cost; (ii) fair value through other comprehensive income; and (iii) fair value through profit or loss. These supersede HKAS 39's categories of held-to-maturity investments, loans and receivables, available-for-sale financial assets and financial assets at fair value through profit or loss. The classification of financial assets under HKFRS 9 is based on the business model under which the financial asset is managed and its contractual cash flow characteristics.

The following table shows the classification categories for the Association's financial assets under HKAS 39 and HKFRS 9.

Financial assets previously classified as loans and receivables (carried at amortised cost) were reclassified to financial assets measured at amortised cost. The carrying amounts as at 31 March 2018 were the same as those as at 1 April 2018.

An explanation of how the Association classifies and measures financial assets and recognises related gains and losses under HKFRS 9 is set out in Note 2(d)(ii).

The measurement categories for all financial liabilities remain the same. The carrying amounts for all financial liabilities as at 1 April 2018 have not been impacted by the initial application of HKFRS 9.

(ii) Credit losses and impairment

HKFRS 9 replaces the "incurred loss" model in HKAS 39 with the "expected credit loss" model. The expected credit loss model requires an ongoing measurement of credit risk associated with a financial asset and therefore recognises expected credit losses earlier than under the "incurred loss" accounting model in HKAS 39. The Association applies the new expected credit loss model to the financial assets measured at amortised cost (including cash at banks, deposits with banks and other financial institutions managed by fund managers, interest and dividend receivables, receivables managed by fund managers and placement with the Exchange Fund). The initial application of the new impairment requirements had no impact on the carrying amounts of the financial assets as at 1 April 2018.

(d) Financial assets and financial liabilities

(i) Initial recognition

Financial assets and financial liabilities are recognised on the date the Association becomes party to the contractual provisions of the financial instruments. They are initially stated at fair value plus or minus directly attributable transaction costs, except for those financial instruments measured at fair value through profit or loss for which transaction costs are recognised directly in surplus or deficit. An explanation of how the Association determines the fair value of financial instruments is set out in Note 13(g). Purchases and sales of investments are recognised using trade date accounting.

(ii) Categorisation and subsequent measurement from 1 April 2018

*Financial instruments measured at fair value through profit or loss*

This category comprises equity securities and trading financial instruments. They are subsequently measured at fair value. Changes in fair value are included in surplus or deficit in the period in which they arise.

Trading financial instruments used by the Association to manage its risks associated with foreign currency fluctuations do not qualify for hedge accounting. They are presented as assets when the fair value is positive and as liabilities when the fair value is negative.

*Financial assets measured at amortised cost*

This category comprises cash at banks, deposits with banks and other financial institutions managed by fund managers, interest and dividend receivables, receivables managed by fund managers and placement with the Exchange Fund. They are held for the collection of contractual cash flows which represent solely payments of principal and interest. They are subsequently measured at amortised cost using the effective interest method, net of loss allowance, if any (Note 2(d)(vii)).

*Financial liabilities measured at amortised cost*

This category comprises payables and other liabilities other than trading financial instruments. They are subsequently measured at amortised cost using the effective interest method.

(iii) Categorisation and subsequent measurement before 1 April 2018

*Trading financial instruments*

These comprise forward currency contracts used by the Association to manage its risks associated with foreign currency fluctuations. Such derivative financial instruments did not qualify for hedge accounting and were categorised as "trading" under HKAS 39. They were carried at fair value, and presented as assets when the fair value was positive and as liabilities when the fair value was negative. Changes in the fair value were included in surplus or deficit in the period in which they arose.

*Financial assets at fair value through profit or loss*

Financial assets at fair value through profit or loss consisted of equity and debt securities that were managed and evaluated on a fair value basis in accordance with a documented risk management and investment strategy. They were subsequently carried at fair value. Changes in the fair value of investments were included in surplus or deficit in the period in which they arose.

*Loans and receivables*

Loans and receivables were non-derivative financial assets with fixed or determinable payments that were not quoted in an active market. This category included cash at bank, deposits with banks and other financial institutions managed by fund managers, interest and dividend receivables and receivables managed by fund managers. They were carried at amortised cost using the effective interest method less impairment losses, if any (Note 2(d)(viii)).

The effective interest method was a method of calculating the amortised cost of a financial asset or a financial liability and of allocating the interest income or interest expense over the relevant period. The effective interest rate was the rate that exactly discounted estimated future cash receipts or payments through the expected life of the financial instrument or, when appropriate, a shorter period to the net carrying amount of the financial asset or financial liability. When calculating the effective interest rate, the Association estimated cash flows considering all contractual terms of the financial instrument but did not consider future credit losses. The calculation included all fees received or paid between parties to the contract that were an integral part of the effective interest rate, transaction costs and all other premiums or discounts.

*Other financial liabilities*

These were financial liabilities other than trading financial instruments. This category included payables and other liabilities. They were carried at amortised cost using the effective interest method.

(iv) Fair value measurement principles

The Association measures its investments in securities and trading financial instruments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either (a) in the principal market for the asset or liability, or (b) in the absence of a principal market, in the most advantageous market for the asset or liability; and the Association has access to these markets at the measurement date.

The fair value of an asset or a liability is measured with those assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their best economic interest.

The Association uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs. The Association measures fair values using the following fair value hierarchy that reflects the significance of inputs used in making the measurements:

Level 1 – fair values are quoted prices (unadjusted) in active markets for identical assets or liabilities;

Level 2 – fair values are determined with inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices); and

Level 3 – fair values of financial instruments are determined with inputs that are not based on observable market data (unobservable inputs).

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Association determines whether transfers between levels in the hierarchy should be reflected in the financial statements by re-assessing categorisation (based on the level of input that is most significant and relevant to the fair value measurement as a whole) at the end of the reporting period.

(v) Derecognition

A financial asset is derecognised when the contractual rights to receive the cash flows from the financial asset expire, or where the financial asset together with substantially all the risks and rewards of ownership have been transferred.

The Association uses the weighted average method to determine realised gains and losses to be recognised in surplus or deficit on derecognition.

A financial liability is derecognised when the obligation specified in the contract is discharged, cancelled or when it expires.

(vi) Offsetting

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position where there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis, or realise the assets and settle the liabilities simultaneously.

(vii) Credit losses and impairment of financial assets from 1 April 2018

For cash at banks, deposits with banks and other financial institutions managed by fund managers, interest and dividend receivables, receivables managed by fund managers and placement with the Exchange Fund, the Association measures the expected credit losses to determine the loss allowance required to be recognised. Financial assets measured at fair value through profit or loss are not subject to the expected credit loss assessment.

Expected credit losses are a probability-weighted estimate of credit losses. They are based on the difference between the contractual cash flows due in accordance with the contract and the cash flows that the Association expects to receive, discounted at the effective interest rate. They are measured on either of the following bases:

- 12-month expected credit losses (for financial instruments for which there has not been a significant increase in credit risk since initial recognition): these are losses that are expected to result from possible default events within the 12 months after the reporting date; and
- Lifetime expected credit losses (for financial instruments for which there has been a significant increase in credit risk since initial recognition): these are losses that are expected to result from all possible default events over the expected life of the financial instrument.

In assessing whether the credit risk of a financial instrument has increased significantly since initial recognition, the Association compares the risk of default occurring on the financial instrument assessed at the reporting date with that assessed at the date of initial recognition. In making this assessment, the Association considers that a default event occurs when (i) the borrower is unlikely to pay its credit obligations to the Association in full; or (ii) the financial asset is 90 days past due. The Association considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

(viii) Impairment of financial assets before 1 April 2018

The carrying amounts of loans and receivables were reviewed at the end of each reporting period to determine whether there was objective evidence of impairment. If any such evidence exists, an impairment loss was recognised in surplus or deficit as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the asset's original effective interest rate. If in a subsequent period the amount of such impairment loss decreased and the decrease could be linked objectively to an event occurring after the impairment loss was recognised, the impairment loss was reversed through surplus or deficit. A reversal of impairment losses was limited to the asset's carrying amount that would have been determined had no impairment loss been recognised in prior years.

(e) Revenue recognition

(i) Interest income

Interest income is recognised in surplus or deficit on an accrual basis, using the effective interest method.

(ii) Dividend income

Dividend income from equity securities is recognised in surplus or deficit when the share price is quoted ex-dividend.

(iii) Net realised and fair value gains/losses

Realised gains or losses on financial instruments are recognised in surplus or deficit when the financial instruments are derecognised. Changes in fair value of trading financial instruments and financial assets at fair value through profit or loss are recognised as fair value gains or losses in surplus or deficit in the period in which they arise.

(iv) Other income

Other income is recognised in surplus or deficit on an accrual basis.

(f) Grants recognition

Grants are recognised as expenditure when they are approved except in those cases where the release of grant is subject to certain conditions, such grants are only recognised as expenditure when the conditions are met.

(g) Employee benefits

Salaries, contract gratuities, annual leave entitlements and the cost to the Association of non-monetary benefits are accrued in the year in which the associated services are rendered by employees of the Association.

Obligations for contributions to defined contribution retirement plan under the Hong Kong Mandatory Provident Fund Schemes Ordinance are recognised as an expense in surplus or deficit as incurred.

Termination benefits are recognised when, and only when, the Association demonstrably commits itself to terminate employment or to provide benefits as a result of voluntary redundancy by having a detailed formal plan which is without realistic possibility of withdrawal.

(h) Foreign currency translation

Foreign currency transactions during the year are translated into Hong Kong dollars at the spot exchange rates at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated into Hong Kong dollars at the closing exchange rates at the end of the reporting period. All foreign currency translation differences are recognised in surplus or deficit. Non-monetary assets and liabilities carried at fair value denominated in foreign currencies are translated at the rates prevailing at the date when the fair value was determined and the exchange differences arising are recognised in surplus or deficit, except for the exchange component of a gain or loss that is recognised directly in equity.

(i) Cash and cash equivalents

For the purpose of the statement of cash flows, cash and cash equivalents include cash at banks and deposits with banks and other financial institutions with original maturity within three months.

**3. Taxation**

No provision for Hong Kong profits tax has been made in these financial statements as the Association is exempted from Hong Kong profits tax under section 88 of the Hong Kong Inland Revenue Ordinance.

**6. Placement with the Exchange Fund**

The balance of the placement with the Exchange Fund amounted to HK\$611.2 million (2018 : HK\$298.5 million), being the principal sums of HK\$591.2 million (2018 : HK\$291.2 million) plus interest paid but not yet withdrawn at the end of the reporting period of HK\$20.0 million (2018 : HK\$7.3 million). The term of the placement is six years from the date of placement, during which the amount of principal sums cannot be withdrawn.

Interest on the placement is payable at a fixed rate determined every January. The rate is the average annual investment return of the Exchange Fund's Investment Portfolio for the past six years or the average annual yield of three-year Government Bond for the previous year subject to a minimum of zero percent, whichever is the higher. The interest rate has been fixed at 2.9% for the calendar year 2019 and at 4.6% for the calendar year 2018.

The Association is a company limited by guarantee and not having a share capital. In accordance with the Association's Articles of Association, the liability of each member is limited by guarantee to HK\$100 each.

The capital fund balance of HK\$3,350 million represents the sum of two grants received from the Government, one for HK\$350 million received in March 1996 and the other for HK\$3,000 million received in June 2010. Under the Association's Articles of Association, the Association is permitted to invest and deal with the moneys of the Association not immediately required for its purposes in or upon such investments, securities or property as may be thought fit subject to such conditions and such consents as may from time to time be imposed by the Financial Secretary or the Secretary for Financial Services and the Treasury.

**13. Financial risk management objective and policies**

**(a) Credit risk**

Credit risk is the risk that an issuer or counterparty will cause a financial loss to the Association by failing to discharge an obligation. The Association's financial assets which are potentially subject to credit risk consist principally of debt securities, bank balances and placement with the Exchange Fund. The credit risk associated with placement with the Exchange Fund is considered to be low. The Association selects issuer or counterparty with good credit standing, strong financial strength and sizable capital. The Association also limits the individual exposure, in accordance with a documented risk management and investment strategy and monitors credit risk on a continuous basis. Hence, the credit risk associated with debt securities and bank balances is also considered to be low. The credit risk on these financial instruments is assessed as not having increased significantly since initial recognition and the Association determines the loss allowance required to be recognised based on 12-month expected credit losses. The Association has estimated that 12-month expected credit losses on these financial instruments are immaterial and considers that no loss allowance is required.

(b) Liquidity risk

Liquidity risk is the risk that the Association will encounter difficulty in meeting obligations associated with financial liabilities. The Association monitors the liquidity requirements on a continuous basis and maintains a level of short-term deposits and cash to pay grants and operating expenses as necessary. Hence the Association does not have significant exposure to liquidity risk.

(c) Currency risk

Currency risk is the risk that the fair value or future cash flows of financial instruments will fluctuate due to the changes in currency exchange rates. The Association's non-Hong Kong dollar investments are exposed to currency risk. The Association only makes investments denominated in Hong Kong dollar, United States dollar and currency of a country whose foreign currency long-term debt has a high credit rating. The Association's exposure to currency risk is handled in accordance with a documented risk management and investment strategy, and the Association monitors the currency risk on a continuous basis.

(d) Interest rate risk

Interest rate risk is the risk that the fair value of financial instruments will fluctuate because of changes in market interest rates. The Association's debt securities stated at fair value are exposed to interest rate risk. Investments in debt securities stated at fair value are made in accordance with a documented risk management and investment strategy, and the Association monitors the interest rate risk on a continuous basis.

As regards deposits with banks, since they are all stated at amortised cost, their carrying amounts and the Association's income and accumulated funds will not be affected by changes in market interest rates.

Equity price risk is the risk of loss arising from changes in equity prices. The Association's equities are subject to the equity price risk inherent in all equity securities i.e. the value of holdings may fall as well as rise. At 31 March 2019, the equity securities were reported as financial assets at fair value through profit or loss as shown in Note 7. The risk is primarily addressed through diversification of investment portfolio in accordance with a documented risk management and investment strategy, and the Association monitors the equity price risk on a continuous basis.

The Association is exposed to financial risk arising from change in the interest rate on the placement with the Exchange Fund which is determined every January (Note 6). (h) Investment management and control

In accordance with Article 3(K) of the Part A of the Articles of Association of the Association, moneys of the Association not immediately required for its purposes shall be invested in such investments, securities or property as may be thought fit subject to such conditions and such consents as may from time to time be imposed by the Financial Secretary or the Secretary for Financial Services and the Treasury.

Article 37 of the Part B of the Articles of Association provides that the business of the Association should be managed by the Governing Committee whose composition is specified in Article 3 of the Part B of the Articles of Association. Pursuant to Article 37 of the Part B of the Articles of Association, the Governing Committee has exercised its power and appointed an Investment Sub-Committee to advise on investment matters.

The principal investment objective is, as far as practicable, to maintain the capital fund intact in the long run and to produce a stable income sufficient to support the annual expenditure of the Association.

The investment management and control of the Association are set out in a documented risk management and investment strategy and reviewed on a regular basis by the Investment Sub-Committee and the Governing Committee.

**14. Possible impact of amendments, new standards and interpretations issued but not yet effective for the year ended 31 March 2019**

Up to the date of issue of the financial statements, the HKICPA has issued a number of amendments, new standards and interpretations which are not yet effective for the year ended 31 March 2019 and which have not been early adopted in the financial statements. The Association is in the process of making an assessment of the impact expected of these amendments, new standards and interpretations in the period of initial adoption. So far, it has concluded that the adoption of them is unlikely to have a significant impact on the Association's financial performance and financial position.
