**Healthy School Depends on You**  
**Invitation for New Round of Applications for**  
**2026/27 School Year “Healthy School Programme”**

The “**Healthy School Programme**” with a **Drug Testing Component** (the Programme) is funded by the Beat Drugs Fund Association (BDFA) and has been actively promoted by the Narcotics Division (ND) and the Education Bureau (EDB) to all secondary schools since the 2011/12 school year. The Programme is now widely recognised by the community. It has allowed students to enjoy a healthy school life and develop a positive and drug-free attitude, which will benefit them for life. In view of this, we continue to implement the Programme and sincerely invite schools and non-governmental organisations (NGOs) to submit funding applications for taking part in the 2026/27 school year so that more students can benefit from the Programme.

The Programme is a school-based anti-drug education initiative, aiming at enhancing the physical and mental health and well-being of students and fostering their resolve to refuse drugs through participating in **diversified personal growth activities** and **voluntary school drug testing**, thereby promoting the cultivation of a healthy and drug-free school culture. Participating schools can apply for funding and integrate it with their current resources to implement the Programme under their existing school-based Healthy School Policy. In previous funding exercises, an **average of around \$460,000<sup>1</sup>** was allocated to each participating school per school year.

<sup>1</sup> The funding includes expenditure for school administrative and logistic support, activities on anti-drug education or personal growth and voluntary drug testing scheme under the Programme.


Under the Programme, a variety of activities was organised in the past, including leadership training, adventure activities, emotional management workshops, growth support groups, career planning workshops, skill training workshops and parenting talks, etc. Participants' feedbacks were positive. Participating schools reflected that most of their teachers, students and parents agreed that the Programme helped foster a drug-free culture in schools and raise their anti-drug awareness, enhanced their knowledge on drugs, and strengthened students' resolve to stay away from drugs and develop healthy lifestyle. Participating schools may partner with suitable NGOs of their choice to implement the Programme. We welcome more NGOs to take part in the Programme, and work together towards the goal of helping students thrive healthily.

We will conduct a **briefing session in March 2026** to introduce the Programme and application details. During the session, representatives of schools currently participating in the Programme would share their experiences. Your school is cordially invited to join the briefing session and you may refer to Appendix 1 for the relevant details.

To join the Programme in the 2026/27 school year, please send us your application on or before 17 April 2026 (Friday). The application form can be downloaded from the "Healthy School Programme" website of ND (<https://www.nd.gov.hk/en/HSP.html>). For the planning of your projects, you may make reference to the latest "Points-to-Note for Applicants" as enclosed (Appendix 2, your special attention is drawn to the requirements of mandatory activities to be implemented under "Programme Design") and the "Reference Protocol for School Drug Testing" available on the above website. The BDFA will examine individual applications and levels of funding support based on factors such as the feasibility of the projects proposed in the applications and the financial status of the Beat Drugs Fund.

**Beat Drugs Fund  
2026/27 School Year “Healthy School Programme”  
Points-to-Note for Applicants**

Schools and organisations preparing to apply for the 2026/27 Healthy School Programme with a Drug Testing Component (HSP(DT)) are advised to read the following points-to-note as references for project planning.

**(I) Anti-drug Theme**

- According to the figures of the Central Registry of Drug abuse (CRDA)<sup>1</sup>, in the first three quarters of 2025, the most commonly abused drugs among drug abusers aged under 21 was etomidate<sup>2</sup>, followed by cannabis and cocaine.
- To combat etomidate-related crimes, the Government listed etomidate and its three analogues (metomidate, propoxate and isopropoxate) as dangerous drugs under the Dangerous Drugs Ordinance on 14 February 2025. Furthermore, all analogues of etomidate were listed as dangerous drugs on 18 July 2025 to ensure that law enforcement agencies can effectively address the threats posed by etomidate. Separately, etomidate is usually consumed by vaping e-cigarettes. From 30 April 2026, the Government will ban the smoking of e-cigarettes and the possession of capsules in public places.
- Some places overseas have relaxed their control on cannabis and it might bring an adverse influence to students in Hong Kong. There is also plenty of false information concerning cannabis on the internet. Regarding cocaine, the amount of cocaine produced worldwide has increased substantially in recent years and drug dealers are trying to sell them to students. We should stay vigilant against it.
- The situation of young people committing drug offences is also worrying. Among the young offenders aged under 21 who were sentenced to imprisonment for drug trafficking, more than half of them were sentenced to over five years in prison. We must help young people stay away from drugs, strengthen their sensitivity in relevant offences, and remind them that young age is not a valid mitigating factor, so as to prevent them from breaching the law inadvertently.
- Drug dealers are eyeing on the increasing popularity of dating apps, encrypted messaging, and online shopping, and making use of them to tempt young people to try drugs or to join related activities.
- With reference to the above latest drug situation, schools and organisations should incorporate the following themes when designing their activities :
  - ✧ **The harms of abusing etomidate, cannabis and cocaine;**
  - ✧ **Serious consequences of committing drug offences, in particular young age**

- ◆ **is not a valid mitigating factor nor would help their acquittal;**
- ◆ **The importance of refusing drugs and involvement in drug offences as well as refusal skills both online and offline.**

## **(II) Programme Design**

- HSP(DT) is a school-based anti-drug education programme comprising two major elements, diversified personal growth activities and students' voluntary participation in school drug testing. To encourage schools and organisations to make good use of **the free anti-drug education resources provided by the Government** for enriching the project contents, schools and organisations must implement the following two types of activities among others:
  - ◆ Arranging students to visit the Hong Kong Jockey Club Drug InfoCentre<sup>3</sup> located in Admiralty (at least once in a school year); and
  - ◆ Showing anti-drug cartoons, video clips or short films<sup>4</sup> on school campus (at least twice in a school year).
- Apart from students' participation, home-school co-operation is also crucial. Schools and families both have powerful impacts to the personal growth of young people. Parents and teachers are often the first line of defence against drug problem amongst youth. Hence, schools and organisations participating in HSP(DT) should **organise activities and trainings to school personnel and parents** to enrich their anti-drug knowledge. In particular, there is a need to help them support students to stay away from drugs and provide suitable assistance to students who encounters drug problems when necessary, as well as to cultivate a healthy and drug-free environment for students.

### Recommended activities

- ◆ Arranging parent-child anti-drug activities (e.g. workshops, visits, etc.);
- ◆ Organising parental anti-drug talks/workshops; and
- ◆ Organising anti-drug training courses for teachers by schools or arranging teachers to attend relevant training courses
- Since the end of 2022, the Narcotics Division (ND) has deployed an anti-drug overarching theme with the slogan “Let’s Stand Firm. Knock Drugs Out!” (“—齊企硬 唔 take 唷”)<sup>5</sup>, a related anti-drug logo, and a pair of anti-drug ambassadors “Agent Don’t” and “Agent Hope”, in its publicity. We strongly encourage schools and organisations to incorporate the above elements when designing the project.
- Schools may incorporate the diversified school programmes into the existing school curriculum or other school activities, including incorporating the HSP(DT) activities into the overall time allocation of “Other Learning Experiences” for a more comprehensive and flexible school plan.

### **(III) School Drug Testing**

- School Drug Test can help strengthen students' resolve to stay away from drugs, build an anti-drug culture in schools and enhance motivation of those in need to seek help.
- The personal data and testing results of any individual student obtained under HSP(DT) will not be passed to Police and other law enforcement agencies.
- Student who has been tested positive or who admitted drug abuse pursuant to HSP(DT) will **neither be prosecuted** for drug consumption **nor expelled** from school.
- Schools and organisations should strengthen the promotion of the school drug testing component of HSP(DT) to parents/guardians, students and other relevant parties through different means, so as to encourage students' participation in the drug testing.
- When planning the school drug testing, schools and organisations should refer to the "Reference Protocol for School Drug Testing" available on the HDP(DT) website<sup>6</sup>.
- Since 2025/26 school year, etomidate has been included in the voluntary drug testing of HSP(DT).

### **(IV) Other Points to Note**

- Applications will be vetted by the Beat Drugs Fund Association (BDFA), and the application results is expected to be announced before August 2026. Schools and organisations with successful application who accepted the grant shall implement the projects in accordance with the programme guidelines. Among others, the guidelines specify that schools and organisations shall comply with all laws and regulations applicable in Hong Kong when implementing the project. The guidelines also set out the procedures and requirements in respect of the accounting arrangement, financial control, quotation procedures, monitoring of funded projects, etc.
- In conducting procurement by using the grant from Beat Drugs Fund, schools and organisations should take into account their continuing duty to safeguard national security and not to engage in any acts or activities which endanger national security. The management of schools and organisations should exercise professional judgment, sensitivity and prudence in assessing any potential national security risks or issues that may be involved in every stage of the procurement. The duty for schools and organisations to safeguard national security is a continuing one that subsists throughout every stage of the entire procurement process, including the pre-contract award stage and the contact management stage after contract award. Schools and organisations shall ensure that each of their procurement documents incorporates specific clauses to disqualify tenderers and to terminate the contract made pursuant to the procurement in the interest of national security.
- BDFA may immediately terminate the project upon the occurrence of any of the following events :
  - ❖ the school or organisation has engaged or is engaging in any act or activity that constitutes or causes, or is likely to constitute or cause, the occurrence of offences endangering national security or that would otherwise be

- ◆ contrary to the interest of national security;
- ◆ the continued implementation of the project is contrary to the interest of national security; or
- ◆ BDFA reasonably believes that any of the events mentioned above is about to occur.

- Schools should observe relevant circulars and guidelines promulgated by the Education Bureau.
